**AGREED ORDER REGARDING SUPERVISED NOTICE AND  
CONDITIONAL CERTIFICATION OF COLLECTIVE ACTION**

Upon motion of the Plaintiff, and agreement of the parties, it is hereby

**ORDERED** that:

(1) Plaintiff may send notice to all other delivery drivers employed by Defendant since March 2006 and working out of the Whirlpool facilities located in Ft. Myers, Orlando, Pompano Beach, and Tampa, Florida, for the purpose of informing them about this lawsuit, their potential rights in the lawsuit, and their right to opt-in as potential plaintiffs;

(2) The content of the notice will be in accordance with the Notice attached hereto as Exhibit A;

(3) Defendant will provide to Plaintiff within 30 days of the entry of this Order, a list of names and last-known contact information for the putative class members listed above;

(4) These putative class members will have 45 days from the date on which Plaintiff receives the contact information from Defendant within which to complete, sign and file the "Notice of Consent to Join," attached hereto as Exhibit B.

It is further

**ORDERED** that Defendant's agreement to the above in no way prejudices its ability to seek decertification of the collective action.
